Policies and Procedures “Pet Transportation”

The safety and security of your pet(s) are the cornerstones of my business. Julspops Dog Walking & Pet/House Sitting Services provides great care for owners who need a helping hand. My services are provided in a reliable, trustworthy, and caring manner.

Booking Request: All booking request must be submitted via email so there is a copy of the request on file. Text message is fine for questions, checking in on your pet(s) but not bookings. Once a booking has been made and confirmed the cancellation policy comes into effect. I know plans can change but please remember I am holding this spot for you.

Cancellations: (a) Bookings made for services **3 days or less** cancellations may be made up to 24 hours in advance of your scheduled service. Cancellations made **LESS** than 24 hours in advance will result in 50% of that service fee.

(b) Bookings made for services **4 days or longer** cancellations may be made up to 5days in advance of your scheduled service. Cancellations made **LESS** than 5 days will result in 50% of that service fee.

If the cancellation is due to a PANDEMIC i.e. COVID-19 obviously they would not be any form of cancellation fee charged. I am the sole owner/operator of Julspops Dog Walking & Pet/House Sitting Services so when you book my time I in turn, turn other booking request away. So, it is important for you (Client) to advise Julspops Dog Walking & Pet/House Sitting Services immediately if your plans have changed.

Duty to Disclose: I represent that I have disclosed and shall continue to disclose, any and all medical conditions or any other conditions, including, but not limited to, personality concerns or behaviors that may affect, limit, or prevent my pet’s ability to participate in services provided by Julspops Dog Walking & Pet/House Sitting Services . I understand that Julspops Dog Walking & Pet/House Sitting Services is relying on and will rely on those representations to provide a safe environment for both humans and animals.

Emergencies: Everyone has them! Feel free to call if an unexpected need arises; I will make every attempt to accommodate your needs for service on short notice depending on my availability.

Fleas & Tick: I agree to inform Julspops Dog Walking & Pet/House Sitting Services if my pet(s) have fleas or ticks and if this maybe the reason my pet(s) are being transported to the groomers and or vet clinic.

Forms: All forms provided to you are **MANDATORY** and must be completed in full. The forms ask for relevant information in case of an emergency as well as information on your pet(s) to allow me to provide the best care possible. In order for Julie Silcock Owner/Operator of Julspops Dog Walking & Pet/House Sitting Services to provide the necessary service(s), please complete all paperwork.

HEALTH: I am aware and understand that Julspops Dog Walking & Pet/House Sitting Services are not veterinarians and do not have backgrounds in animal medicine. I agree to assume all risk associated with the administration of medication by Julspops Dog Walking & Pet/House Sitting Services during my pet's care. In addition, I acknowledge and am aware that vaccines do not protect against all contagious illnesses that may affect my pet(s). I HEREBY AGREE TO INDEMNIFY JULSPOPS DOG WALKING & PET/HOUSE SITTING SERVICES, ITS OWNER, AGAINST ANY CLAIMS MADE AS A RESULT OF MY FAILURE TO INFORM JULSPOPS DOG WALKING & PET/HOUSE SITTING SERVICES OF ANY PRE-EXISTING MEDICAL CONDITIONS THAT MY PET(S) MAY HAVE.

Holiday Surcharge: Julspops Dog Walking & Pet/House Sitting Services will charge a PRIME RATE for Christmas EVE/DAY & New Years EVE/DAY please ask for pricing. If any other service falls on any other Statutory/Civic Day an additional charge of \$5.00 per visit will apply.

HOME: Julie Silcock Owner/Operator of Julspops Dog Walking & Pet/House Sitting Services has FULL authorization to enter my home to provide the necessary service(s) booked to care for my pet(s)

Hours of Operation: Hours are **6am to 8pm Monday to Sunday,** Other times can be considered.

Inclement Weather: Should I be unable to transport your pet due to poor weather conditions; Julspops Dog Walking & Pet/House Sitting Services will contact you by phone to let you know the service has been cancelled.

Keys: A key or excess to my home will be provided to Julspops Dog Walking & Pet/House Sitting Services if transportation is being provided whilst I am away from my home. I will complete the key handing agreement if this situation arose.

Payment - Accepted methods of payment are cash or etransfer. Payment is required at **START** of service and is subject to HST. Invoice will be provided.

Julspops Dog Walking & Pet/House Sitting Services reserves the right to deny service or terminate service because of safety concerns, financial issues, failure to comply with policy, or inappropriate or uncomfortable circumstances.

Pet Behavior: I agree to be solely financially responsible for any and all acts or behavior of my pet(s) while in the care of Julspops Dog Walking & Pet/House Sitting Services, WHICH MAY INCLUDE

PAYMENT OF DAMAGES FOR THE INJURY CAUSED BY MY PET(S) TO OTHER ANIMALS, HUMANS, AND/OR JULSPOPS DOG WALKING & PET/HOUSE SITTING SERVICES. IN ADDITION, I AGREE THAT IF MY PET(S) IS INJURED BY ANOTHER PET, I HEREBY RELEASE JULSPOPS DOG WALKING & PET/HOUSE SITTING SERVICES, FROM ALL LIABILITY AND FINANCIAL RESPONSIBILITY FOR SUCH INJURY. I FURTHER UNDERSTAND THAT IF MY PET(S) BITES A HUMAN OR PET, THAT JULSPOPS DOG WALKING & PET/HOUSE SITTING SERVICES WILL MAKE EVERY EFFORT TO CONTACT ME IMMEDIATELY.

I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THIS AGREEMENT AND UNDERSTAND THAT I WILL GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT. I HAVE SIGNED THIS AGREEMENT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY JULSPOPS DOG WALKING & PET/HOUSE SITTING SERVICES.
